# Anatomy & Physiology of the Spine & Functional Anatomy of the Spine

### **Outcomes**

- To have an understanding of the structure and basic anatomy of the individual components of the spine
- To understand the normal function of the components of the spine and how they interact
- To have an understanding of the ageing process of the various components of the spine
- To have an understanding of the biomechanical stresses caused by various postures and positions of the body

# Principles and 24 Hour 'Good Back Care'

#### **Outcomes**

- To have an understanding of 'postures' to avoid to prevent long term musculo-skeletal problems
- To link 'good back care' with activities of daily living and have strategies to know how to look after our backs
- To have an understanding of the basic principles of safer moving and handling and to begin to practise adapting and using these principles
- To develop techniques for handling inanimate loads and to adapt those techniques using problem-solving skills

- To be able to use and adapt the principles of safer moving and handling
- To provide the opportunity to practice practical techniques under supervision
- To understand the importance of establishing normal movement patterns for clients and encouraging independence
- To be able to analyse practical techniques and evaluate them based on the risk assessment process

- To discuss and formulate a strategy for dealing with staff who may persist in performing unsafe handling techniques

# How people learn and Presentation/Demonstration Skills

#### **Outcomes**

- To develop an understanding of how people learn
- To have an understanding of the barriers to learning
- To understand the principles of demonstrating practical skills, and to be able to analyse common pitfalls relating to the demonstration of manual handling techniques to trainees
- To learn how to set aims and outcomes for training sessions that are specific to learners needs

# Mobile hoists and slings

#### **Outcomes**

- To understand the principles of hoisting: why and when to hoist
- To have an awareness of the differences between the main types of hoisting equipment available
- To be able to demonstrate the correct use of a hoist
- To be able to select the correct hoist and sling dependant on their client's individual needs

# **Object handling**

- To use problem solving skills to identify risks in non-patient handling areas and discuss ways to reduce risk
- To be able to adapt principles and basic techniques to find realistic solutions to common problem areas

### Day 4

# Moving & Handling for clients who fall or are found on the floor Outcomes

- To be able to identify steps to reduce the risk of clients falling
- To use a problem-solving approach to identify techniques to deal with clients who have fallen on the floor
- To identify equipment that may be needed for clients who have fallen
- To learn techniques to assist clients on and off the floor when necessary (for play, for physio, in emergencies etc)

# **Problem solving session**

- To work in groups, using a moving and handling problem, to identify risks
- Using a balanced approach, to identify strategies, techniques and equipment to help to reduce the risk to the lowest level reasonably practicable
- To be able to share experiences and 'good' practise in a small group environment
- To be able to present the 'problem' to the whole group and to demonstrate the techniques/ideas discussed
- To identify, and then present to the group, strategies to request additional resources, funding or training
